Precisely at midnight on Saturday, March 14<sup>th</sup>, the conclusion of the 2015 Legislative Session decided the fate of several pieces of legislation. The outpouring of activism by teachers and school service personnel had a direct impact on the outcome of this session. # SB 14 - WV Public Charter Schools (FAILED)

SB 14 allowed the creation of public charter schools in WV. The bill appeared to be on the fast track early in the session but even with many delays, it still passed the Senate. After being advanced by the House Education and Finance committees, SB 14 seemed to be set for passage. However, the bill was scheduled for third reading on the House floor when it was abruptly placed at the bottom of the House calendar. SB 14 remained at the foot of the calendar until the gavel fell at midnight, despite a late attempt to amend it into another bill. Additionally, a resolution to study charter schools also fell short on the last day of the session. The ultimate demise of the charter school bill is a tremendous victory for public education and the outcry from education employees was a key factor in the momentum shift for this bill.

### **HB 2005** – Alternative Certification (PASSED)

In its original form, HB 2005 expanded alternative certification programs in WV to address teacher shortages in the state. The bill would have lowered standards for program entry by allowing anyone with a bachelor's degree to teach any subject area or grade level without additional training. Once again, thanks to the thousands of emails and calls, the Senate Education Committee made several amendments to the bill, addressing many of AFT-WV's concerns.

The amended version allows hiring alternative certification teacher candidates only in areas of critical need regarding shortages. Provisions were included to prevent the displacement of traditionally certified teachers by alternatively certified individuals in matters of hiring and reduction in force. Language in the bill was strengthened to guarantee the content area expertise of alternative certification candidates. Professional development requirements were added, ensuring the alternative certification program provides candidates additional courses in areas such as child development and learning, classroom management, educational technology and curriculum.

#### HB 2934 Repeal of the Common Core Standards (FAILED)

HB 2934 called for a complete repeal of the Common Core Standards in WV and quickly passed the House of Delegates. Due to concerns that the bill would leave WV with no standards and cost the state well over \$100 million, the Senate amended the bill to require a review of the standards. Revised HB 2934 passed the Senate but died when the House refused to concur with the Senate's changes.

# HB 2939 Requirements for mandatory reporting of sex offenses involving students (PASSED)

This bill clarifies the reporting requirements of school employees who witness or receive disclosure of sexual offenses involving students. School employees are required to report these matters to their principal immediately, but not more than 24 hours of the incident becoming known. The bill requires administrators to report the incident to the State Police within 24 hours.

#### SB 537 Changing mandatory school instructional time from days to minutes (FAILED)

SB 537 would have changed current law regarding instructional time from days to minutes, allowing local boards of education to use minutes beyond the required amount, or "banked time," for lost instructional days. The bill would have been effective immediately, potentially assisting county boards in offsetting lost instructional days for the current school year. However, the House and Senate could not concur on amendments to the bill, and it failed to pass on the final day of the legislative session.
