Senate amends and advances tobacco tax to fund PEIA

On Wednesday, the Senate Finance Committee advanced SB 420, a bill designed to raise the state's tobacco tax and fund the PEIA deficit.

After much deliberation, Gov. Earl Ray Tomblin's original proposal for a 45 cent raise was amended to a full \$1 increase, in an effort to fund the \$120 million PEIA shortfall. The current cigarette tax is 55 cents per pack. Tomblin's 45 cent proposal would have made the tax an even \$1.

Sen. Roman Prezioso proposed the amendment to raise the tax to \$1.55, which would raise \$43 million more annually than the governor's proposal. The tax would also include a lesser tariff on products such as e-cigarettes and smokeless tobacco products such as dip or pouches. SB 420 now awaits consideration by the full Senate.

Over 230,000 West Virginians will be hurt by the \$120 million in proposed PEIA benefit cuts unless a funding stream is passed by the legislature. Please continue to contact your representatives and ask them to fix and fund PEIA by supporting SB 420.

Common Core

A Committee Substitute for HB 4014 was discussed by the House Education Committee on February 10th and 11th. The bill would prohibit the use of common core standards, the smarter balanced assessment and the recently revamped WV standards. Delegate John Kelly (R-Wood) invited Wood County Director of Curriculum Christy Willis to speak against the repeal. Staff from WVDE, SBOE, State Superintendent and counsel for House Education answered questions over the course of two days. The only person to speak in support of repealing the standards was an out-of-state lobbyist working for the Koch-funded American Principles Project. If passed, the cost to public education in our state is unclear and would cause yet another change in direction for WV teachers and students. At press time, HB4014 is on the agenda again for today's House Education meeting.

School Calendar bill changes 180 days to minutes

AFT-WV supports school calendars that provide thorough instructional time and allow local communities to develop calendars to fit their unique needs. SB 313 changes mandatory school instructional time from 180 days to minutes and permits limited use of available accrued instructional time. The bill was amended on a voice vote during 2nd reading and is on 3rd reading in the Senate.

Both chambers override Governor Tomblin's vetoes

<u>HB 4005</u> repealed prevailing wage laws for publicly financed construction projects, which will enable cheap, often undocumented workers from out of state corporations to under bid projects and utlimately result in lower wages and less jobs for thousands of West Virginians in the construction trades. <u>SB 1</u> makes WV a Right to Work state. Right to Work legislation is designed to weaken unions. It creates government intrusion in employer-employee negotiations and forces unions to bargain for and represent non-dues paying employees in the bargaining unit.

The House and Senate overrode Governor Tomblin's veto of the Prevailing Wage repeal and Right to Work legislation. Both pieces of legislation will become effective 90 days from passage. The passage of both bills will result in lower wages and diminished workplace rights and safety for West Virginia workers.

Charter Schools bill still awaiting action in House

The House Education Committee still has not taken up the charter schools bill. HB 4011 is more troublesome than last year's charter schools bill because it removes local community and employee buy-in, while allowing service personnel jobs to be contracted out to private companies or out-of-state corporations. The national trend of mismanagement and fraud in Charter Schools is not what we need in West Virginia. **AFT-WV opposes HB 4011.**
