Standing 55 Strong...From Statehouse to Schoolhouse

March 11, 2019

Regular session ends, special session on education called

While the 2019 Regular Session of the WV Legislature ended on Saturday, it feels more like a hiatus than a conclusion to education employees. The Senate leadership never took up HB 2730, the Governor's "clean" 5 % pay raise bill, despite Senate President Carmichael being on record to "guarantee" it's passage in October 2018. The announcement of a special session by Governor Jim Justice brings mixed feelings of appreciation for the Governor's determination in providing the promised raises coupled with skepticism at the probable resurfacing of defunding schemes like charter schools and ESAs. While the pay increase is much needed, the legislative leadership should be reminded that education employees did not strike over a pay raise and we will approach the special session with a suspicious eye.

Our union and our members welcome the opportunity to offer their expertise on ways to improve student achievement like lower class sizes and increased mental health and counseling services for students. AFT-WV

Bills passed relating to PEIA Funding HB 2665

HB 2655 appropriates the \$105 million of the funding promised by Gov. Justice into the PEIA Rainy Day Fund to shore up the Public Employees Insurance Agency. This funding stabilizes costs and premiums (may be used to reduce or prevent benefit cuts and/or reduce premium increases) through plan year 2021.

HB 3139

HB 3139 creates the PEIA Rainy Day Fund and fee. The fund was created in order to place and use the \$105 million appropriated by HB 2665.
